PURPOSE: The purpose of this hearing is to examine the overall effectiveness of mayoral control of the New York City School District

Chapter 91 of the Laws of 2002 and Chapter 123 of 2003 established a centralized, mayoral control system of governance for the New York City School District. In 2019, the legislature extended the provisions of mayoral control for three years, until June 30, 2022, and included provisions to increase parental involvement on the Panel for Education Policy and Community District Education Council. This hearing will be the first in a series of hearings and other informational forums throughout the City of New York to assess the effectiveness of mayoral control of the New York City School District and hear from stakeholders on the ways to address the inequities in our schools and improve student performance.

The purpose of this hearing is to comprehensively examine the overall effectiveness of mayoral control of the New York City School District and to identify issues pertaining to school governance in New York City. This will allow the Committee to focus subsequent hearings on specific topics in order to examine possible reforms to mayoral control.

Persons wishing to present testimony should complete and return the enclosed reply form no later than Wednesday, December 11, 2019. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

Oral testimony will be limited to **five (5) minutes** duration. Witnesses are encouraged not to read their statements verbatim, but to instead summarize the key points raised therein. In preparing the order of witnesses, the Committee will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible.

Twenty (20) copies of any prepared testimony should be submitted at the hearing registration desk. The Committee would appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

In order to meet the needs of those who may have a disability, the Assembly, in accordance with its policy of non-discrimination on the basis of disability, as well as the 1990 Americans with Disabilities Act (ADA), has made its facilities and services available to all individuals with disabilities. For individuals with disabilities, accommodations will be provided, upon reasonable request, to afford such individuals access and admission to Assembly facilities and activities.
